 Commence at the Southeast corner of Section 25, Township 21 South, Range 29 East run South 89 degrees 36 minutes 42 seconds West, 713.88 feet along the South line of the Southeast quarter of said Section 25 to the Southerly projection of the existing West right of way line as shown on the Florida Department of Transportation Right of Way Map for State Road No. 15 & 600, Section No. 75030-2205 & 75030-2502 on file at the Florida Department of Transportation District Five Office, Surveying and Mapping Section, Deland, Florida run North 00 degrees 06 minutes 42 seconds East, 41.71 feet along said Southerly projection and existing West right of way line to the POINT OF BEGINNING; thence departing said existing West right of way line, North 89 degrees 38 minutes 31 seconds West, 0.60 feet to a point; thence North 00 degrees 21 minutes 29 seconds East, 20.56 feet to a point; thence North 89 degrees 38 minutes 31 seconds West, 0.96 feet to a point; thence North 00 degrees 21 minutes 29 seconds East, 172.83 feet to a point; thence South 89 degrees 38 minutes 31 seconds East, 0.84 feet to the said existing West right of way line and also known as Point A; thence South 00 degrees 06 minutes 42 seconds West, 193.39 feet along said existing West right of way line to the POINT OF BEGINNING.
